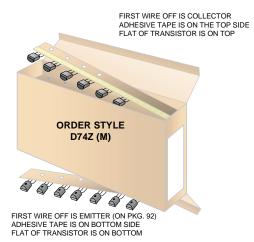


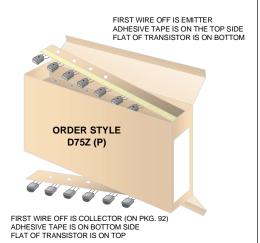

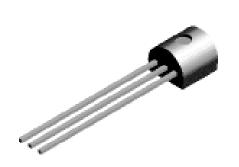


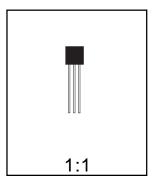


TO-92 Package Dimensions



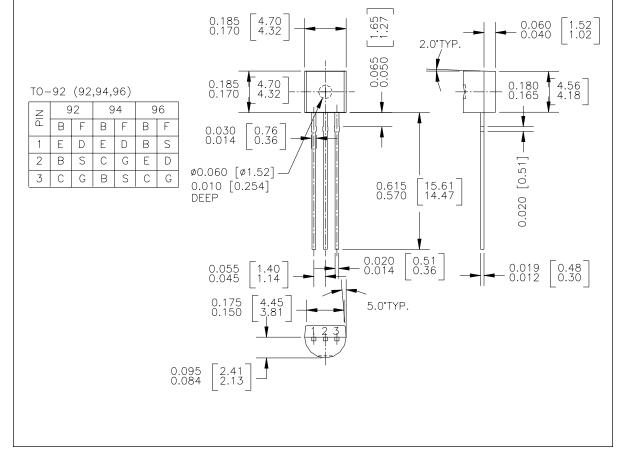

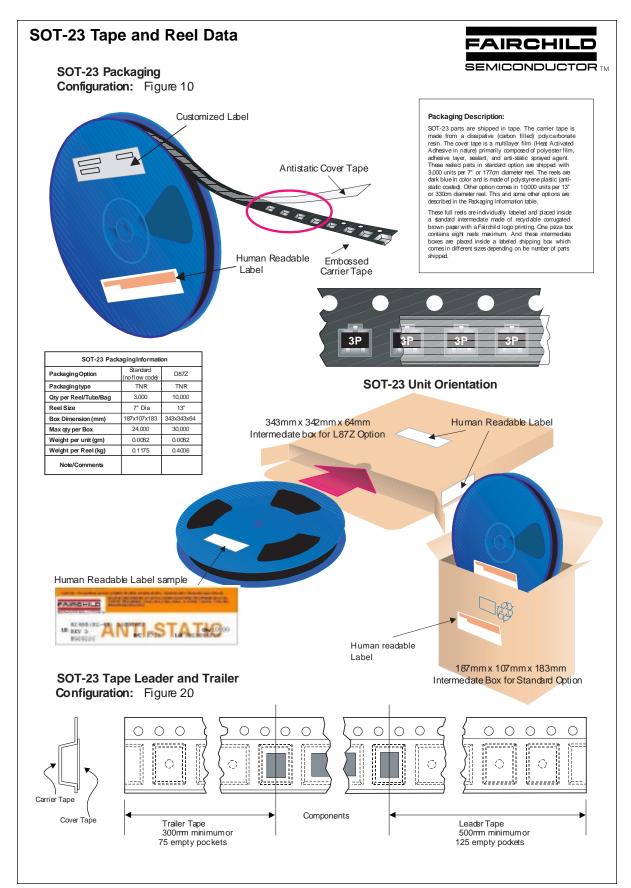

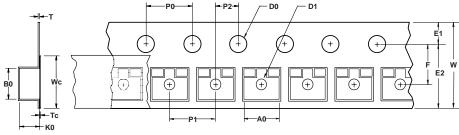

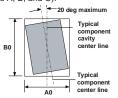

Component Rotation

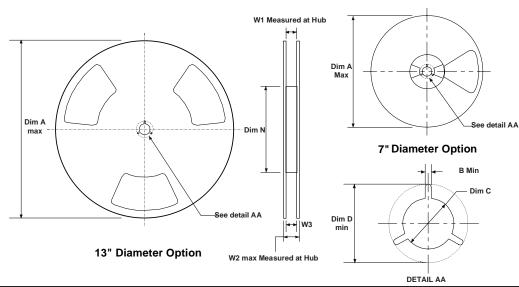


Sketch B (Top View)

Component lateral movement

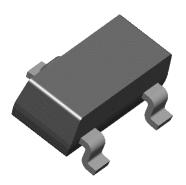
